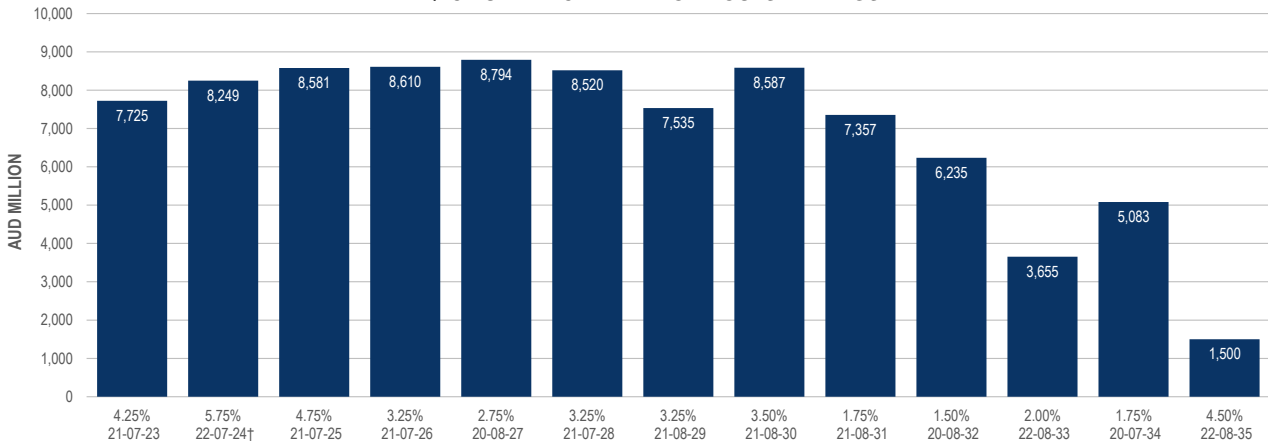

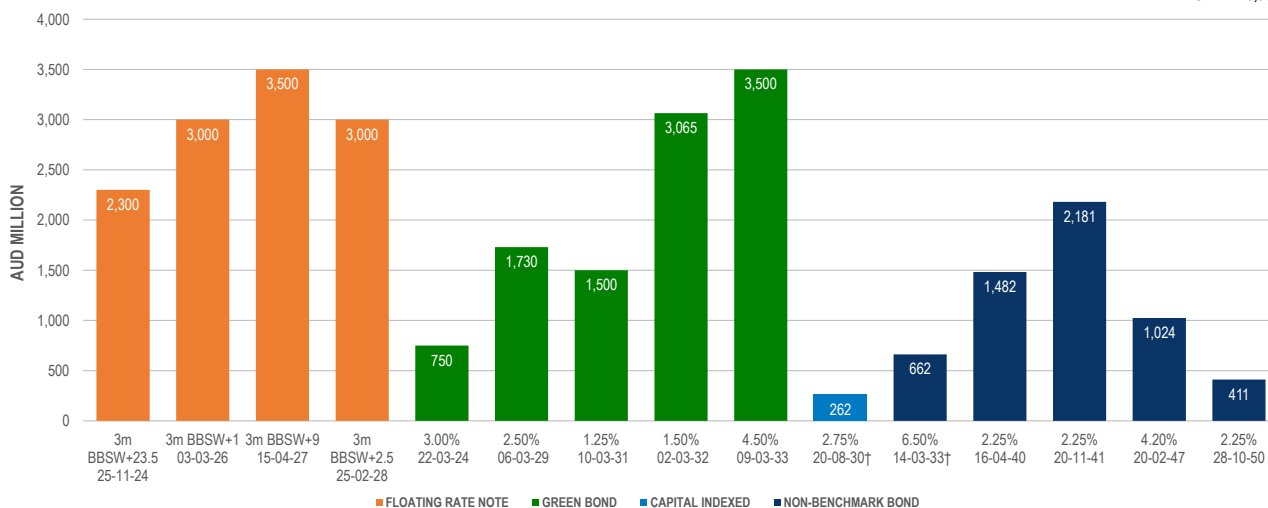
QTC AUD BENCHMARK BOND OUTSTANDINGS
