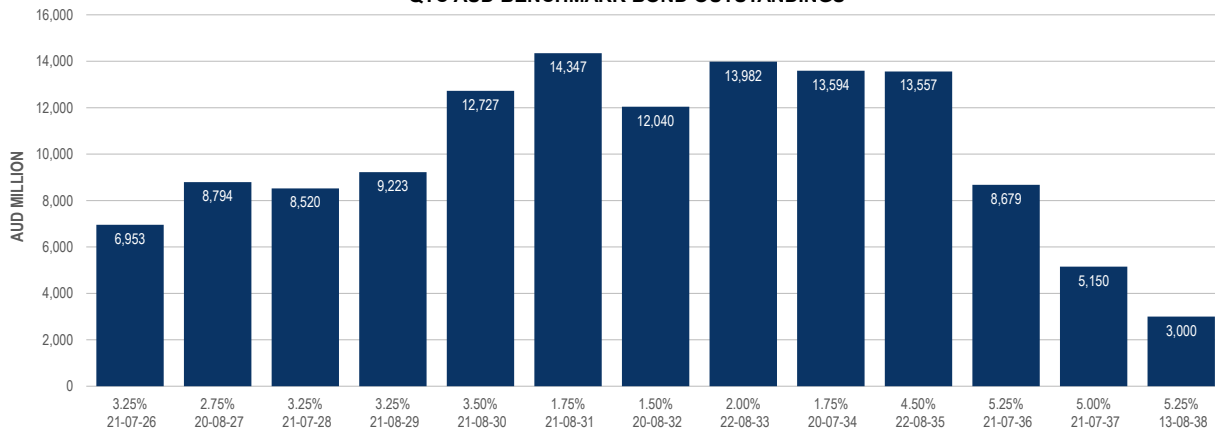

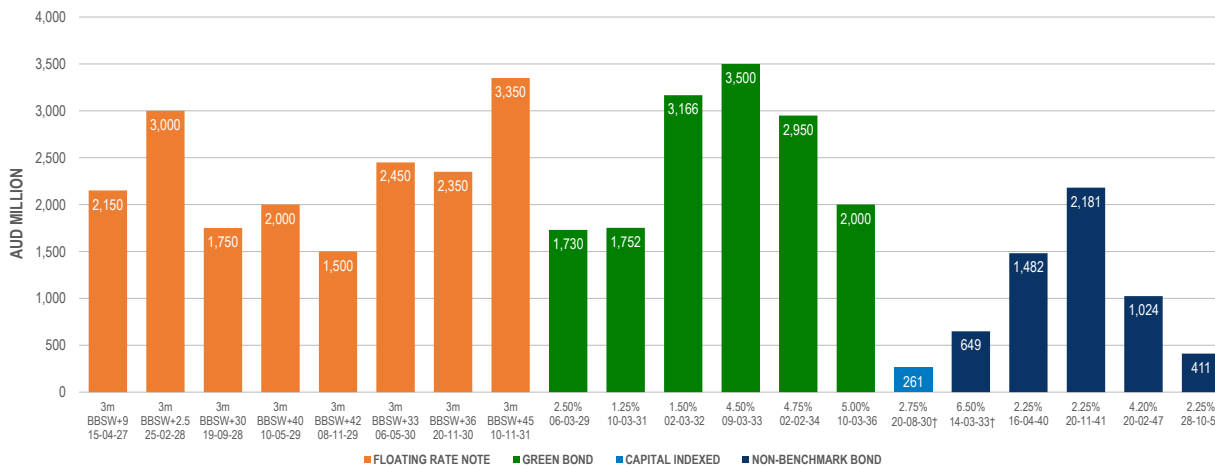
## QTC AUD BENCHMARK BOND OUTSTANDINGS
